## 2. Applicant Profile

Firms possessing the requisite eligibility (pre-qualification criteria), experience and expertise in providing project management consultancy for forestry sector with requisite financial strength, may submit their Expression of Interest (EoI), in the Prescribed Formats only, with relevant information/supporting documents.

Applicants are expected to be precise and not provide any unnecessary or irrelevant documents/information.

The application should be sent through registered post in a sealed cover, in duplicate. Sealed EoI should be submitted to the Office of the Chief Executive Officer, Uttarakhand CAMPA so as to reach on or before 5:00 PM on 15<sup>th</sup> April 2025. EoIs received in formats other than the rescribed Formats and/or received after the due date and time shall not be entertained.

The applicant would be required to satisfy the following eligibility criteria as pre-qualification criteria for submitting their EOI. The EOI of the Firms not meeting the minimum criteria will not be evaluated. Therefore, The Firms not meeting these minimum criteria need not apply.

### 3. Eligibility (pre-qualification criteria)

#### 3(a). Technical

- Minimum 5 years of working experience in India in providing similar services (Natural Resource Management sector) as project management consultancy.
- The firm must have successfully completed minimum two assignments of similar nature for Government Departments/PSUs in India of value not less than Rs.30 lakh in last 5 years (copy of work order and completion certificates mandatory).

- The applicant organization must be net worth positive having a minimum annual turnover of INR 50 lakh in the last 3 years. Auditors certificate supported with Income Tax returns for last three financial years to be submitted along with the EOI.
- The firm should be registered under GST, Provident Fund, ESI and must not be a defaulter of Income Tax. Copies of GST, PF, ESI registration to be submitted along with the EOI.
